

## Your Home Girls – Community Organizing Giveaway Privacy Policy

Your Home Girls (“we,” “us,” or “our”) respects your privacy and is committed to protecting personal information collected during the Community Organizing Giveaway for residents of Seattle, WA and Los Angeles, CA. This policy explains what information we collect, how we use it, and your rights regarding your personal data.

### 1. Information We Collect

- Name, address, email, and phone number
- City of residence
- Photos or video of spaces to be organized
- Short background or story submitted for nomination
- Any other information voluntarily provided in submissions

### 2. How We Use Your Information

We use participant information to:

- Administer the giveaway, including verifying eligibility and notifying winners
- Schedule and conduct organizing sessions
- Share winners’ stories, photos, or videos for marketing, social media, and community outreach purposes, if consent is given
- Communicate about related services or future events (only if opted in)

### 3. Sharing Your Information

- Participant information will not be sold.
- We may share necessary information with:
  - Sponsors supporting the giveaway
  - Service providers assisting with giveaway administration
- All shared information will be used only for purposes related to the giveaway and handled securely.

### 4. Participant Rights

For residents of California (CCPA/CPRA):

- Right to know: Request access to personal information collected.
- Right to delete: Request deletion of personal information collected.
- Right to opt-out: Opt-out of sharing or selling personal information (not applicable to this giveaway as we do not sell data).
- Right to limit use of sensitive information.

### 5. Data Retention

Personal information will be retained only as long as necessary to administer the giveaway and for legal or business purposes.

## 6. Security

We implement reasonable administrative, technical, and physical safeguards to protect personal information.

No method of transmission or storage is 100% secure; by participating, you acknowledge that some risk remains.

## 7. Consent

By submitting a nomination, participants consent to the collection, use, and sharing of their information as described in this policy.

Participants may opt out of marketing communications separately by contacting us or using opt-out links in communications.

## 8. Publicity Release

Winners consent to allow Your Home Girls to use their name, photo, video, and story for promotional purposes unless prohibited by law.

## 9. Federal Privacy Compliance

We comply with all applicable federal laws, including the Federal Trade Commission (FTC) Act for truthful marketing and advertising, and Children's Online Privacy Protection Act (COPPA) if applicable (participants are 21+ so COPPA does not apply directly).

## 10. Changes to this Policy

We may update this privacy policy to reflect changes in our practices or legal requirements. Updates will be posted on our website and effective immediately upon posting.
